Some people shot off fireworks, like millions of other Americans that day. Someone spray painted a wall. As the rally dispersed, a police officer pulled a gun, aiming at protesters as they left. In a common defensive practice, one individual, an ex-Marine, fired multiple suppressive rounds at the ground. This action likely saved the lives of the other attendees. Police claim that a bullet – likely a ricochet – grazed the shoulder of the officer, who was fine and released from a nearby hospital within hours.

But the Trump administration leapt at this opportunity, weaving an elaborate tale of an imaginary Antifa cell and a calculated ambush. State and federal police arrested 9 people that night, and 10 more over the following months.

The first federal trial concluded two weeks ago, and the misconduct should alarm us all. We saw a Trump appointed judge dismiss a jury for its vocal support of the first and second amendment.
